Chevron U.S.A. Inc. (OGRID: 4323) seeks administrative approval for a Central Tank Battery/Off Lease Measurement Facility to commingle oil and gas production from the Purple Sage;Wolfcamp (Gas) (98220) and Culebra Bluff;Bone Spring South (15011) pools for the attached list of existing and future wells and leases drilled within the mentioned areas of diverse ownership in Sec. 14 and 23 T23S-R29E & Sec. 25 and 36, T32S-R28E, Eddy County, New Mexico. Copies of the certified C-102 for each well and facilities supporting documents are included with this notification.

Pursuant to NMAC 19.15.12.7, approved spacing units with diverse ownership are considered separate leases for commingling purposes. Chevron USA Inc. is requesting approval to commingle production according to the provisions of NMAC 19.15.12.10.C for all existing and future wells in these separate areas of diverse ownership at the Culebra Bluff Sec. 23 Central Tank Battery in UL: O, T23S-R28E. Pursuant to 19.15.12.10(C)(4)(g), Chevron USA Inc. requests authority to produce future leases with notice provided to only the interest owners of the future wells on these leases.

Names of all WIO and RIO are included with this request. All owners have been notified of this request and that each will have 20 days with which to object to the commingling request per NMOCD Rule 19.15.12.10 Surface Commingling C. (4) c.

The Culebra Bluff 23 Central Tank Battery is located in the S2SE (UL: P), Sec. 23, T23S-R28E. The Culebra Bluff 26 Compressor Station is located in Section 26, T23S R28E. CB BERU wells are located in Section 14 & 23, T23S R29E. CB CAL wells are located in Section 25 & 36, T23S R28E.

This facility will be commingling new wells (quantity 10), CB CAL 25 36 STATE COM 08 401H, 402H, 403H, 302H and 303H; and CB BERU 23 14 FEE 06 401H, 402H, 403H, 301H and 302H; and are targeted to begin producing in March and May 2021 respectively.

The 401H, 402H, and 403H wells are in the Purple Sage/Wolfcamp formation and 302H and 303H wells are in the Bone Spring formation. CB BERU 23 14 FEE 06 401H, 402H, 403H wells are in the Purple Sage/Wolfcamp formation and 301H and 302H wells are in the Bone Spring formation.

Well production will be allocated based on a production curve from well tests, tested at a frequency of once every 3 days during the initial production phase before peak production is reached but not to exceed 30 days. For each well, during the plateau period and while decline rate is greater than 22%, the oil and gas production shall be allocated using a minimum of three (3) well tests per month. During the final stages of the well decline period, each well will be tested at a frequency of two (2) well tests per month when the decline rate is between 22% and 10% per month; and one (1) well test per month when the decline rate is less than 10% per month.

APPLICATION FOR COMMINGLING AT A COMMON CENTRAL TANK BATTERY Chevron U.S.A. Inc.

Culebra Bluff Central Section 23 Tank Battery

Oil & Gas metering:

The central tank battery (Culebra Bluff Central 23 CTB) is located in the S2SE corner of Sec. 23, T23S-R28E. The wells from the Bone Spring Pool and the Purple Sage/Wolfcamp Pool will be commingled through a common production train (Train 1) for separation and measurement. Additionally, wells from CB BERU Section 14 & 23, T23S R29E lease and CB CAL Section 25 & 36, T23S R28E lease will also be commingled through the same production train (Train 1).

For gas, there will be a common central delivery point (CDP) gas sales at the Culebra Bluff Central gas compression station in Section 26, T23S R28E. that takes combined suction gas from Culebra Central CTB 23. This compressor station sends gas either to a High Pressure sales point (Targa) or to a gas lift system. The produced water will go to common water tanks on location and then to NGL (third party) water disposal station.

Flash gas from the Tanks & the Heated Vessels (Heated Production Separator & Heater Treater) will be compressed via the VRU/FGC system and sent through the common facility gas meter before leaving the CTB.

Oil from all wells will be sent to common oil tanks and sold through common LACT units (SN 1912E10170 and 1945E10151). All wells will be tested monthly in order to meet all federal and state requirements regardless of the phase of decline. The value of gas and oil will not be affected due to different formations as BTUs & API gravities are expected to be the same or similar.

Gas Processing:

Gas from Culebra Bluff Central 23 CTB will flow to the Culebra Bluff Central 26 Compressor Station. The CTB's gas will be continuously measured utilizing orifice meters fitted with EFM flow computers located at Culebra Bluff Central 23 CTB (SN 160108778 and SN 160108785) prior to entering the Compressor Station suction. Gas will be compressed and utilized for gas lift of all wells producing into Culebra Bluff Central 23 CTB. Total gas lift volumes for each well will be measured through individual well gas lift orifice meters fitted with Total Flow EFM flow computers as well as a common gas lift meter at the compressor station outlet for total gas lift volume via Total Flow EFM (SN TBD).

Flaring in the event of an upset will also be measured with a thermal mass meter fitted with an EFM Flow Computer (SN TBD). This flare meter is located upstream of the common Targa sales orifice meters/FMP.

Process and Flow Descriptions:

The flow of production is shown in detail on the enclosed facility flow diagram and map which shows the lease boundaries, location of wells, and locations of the flow lines, facility, and gas sales meter. The commingling of this will not result in reduced royalty or improper measurement of production. The proposed commingling will reduce the surface facility footprint and overall emissions.

Chevron U.S.A. Inc. understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.

Crude Statement

- Chevron will receive the same sales price for all crude production in this area, and surface commingling of these pools will not change the value of the crude sales price under current contract terms.

Gas Statement

- The commingling of gas between the captioned wells will not have an impact on the value of the production and Chevron will receive the same sales price, as the same gathering and processing fees are expected to apply to all gas production.

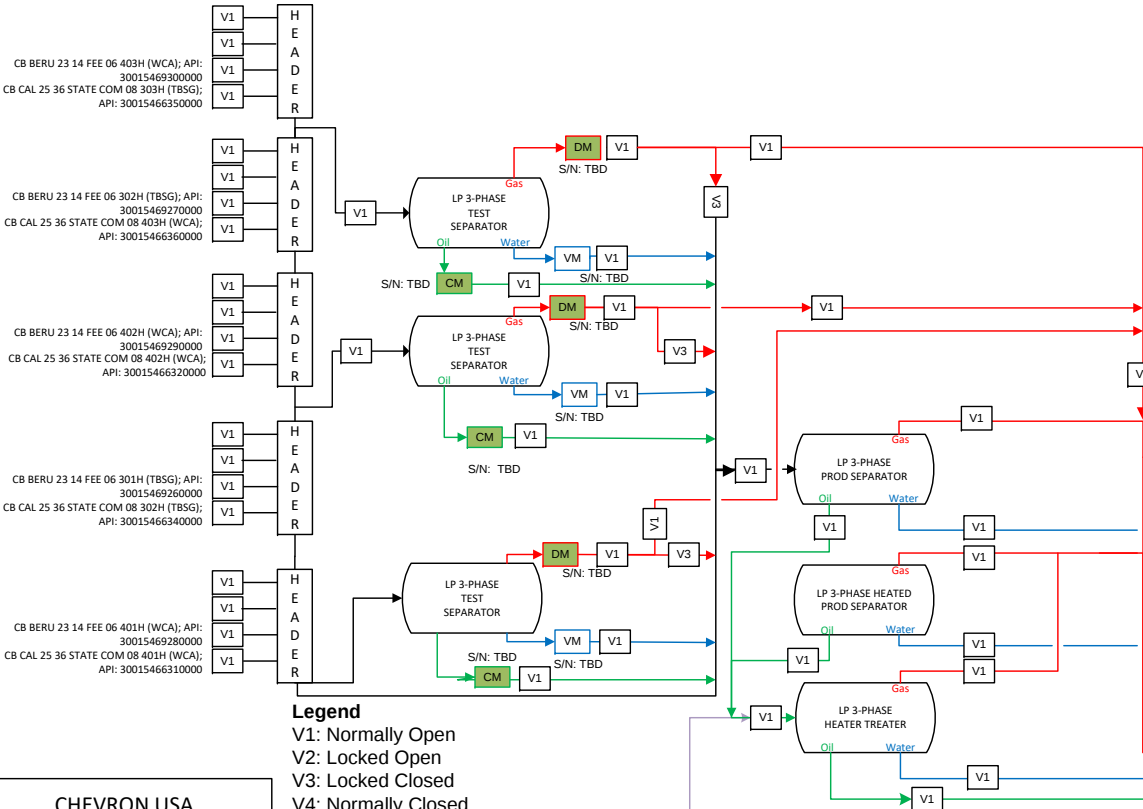

Culebra Bluff Central 23 CTB - Train 1

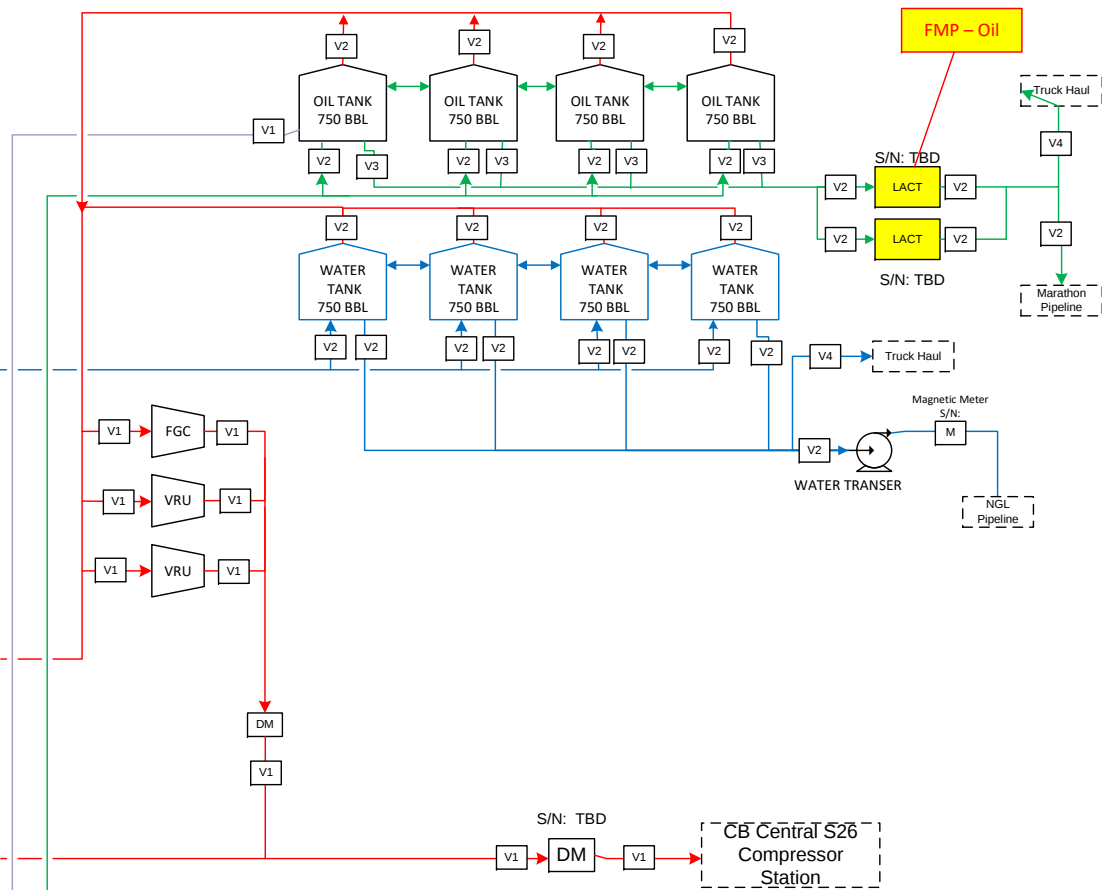

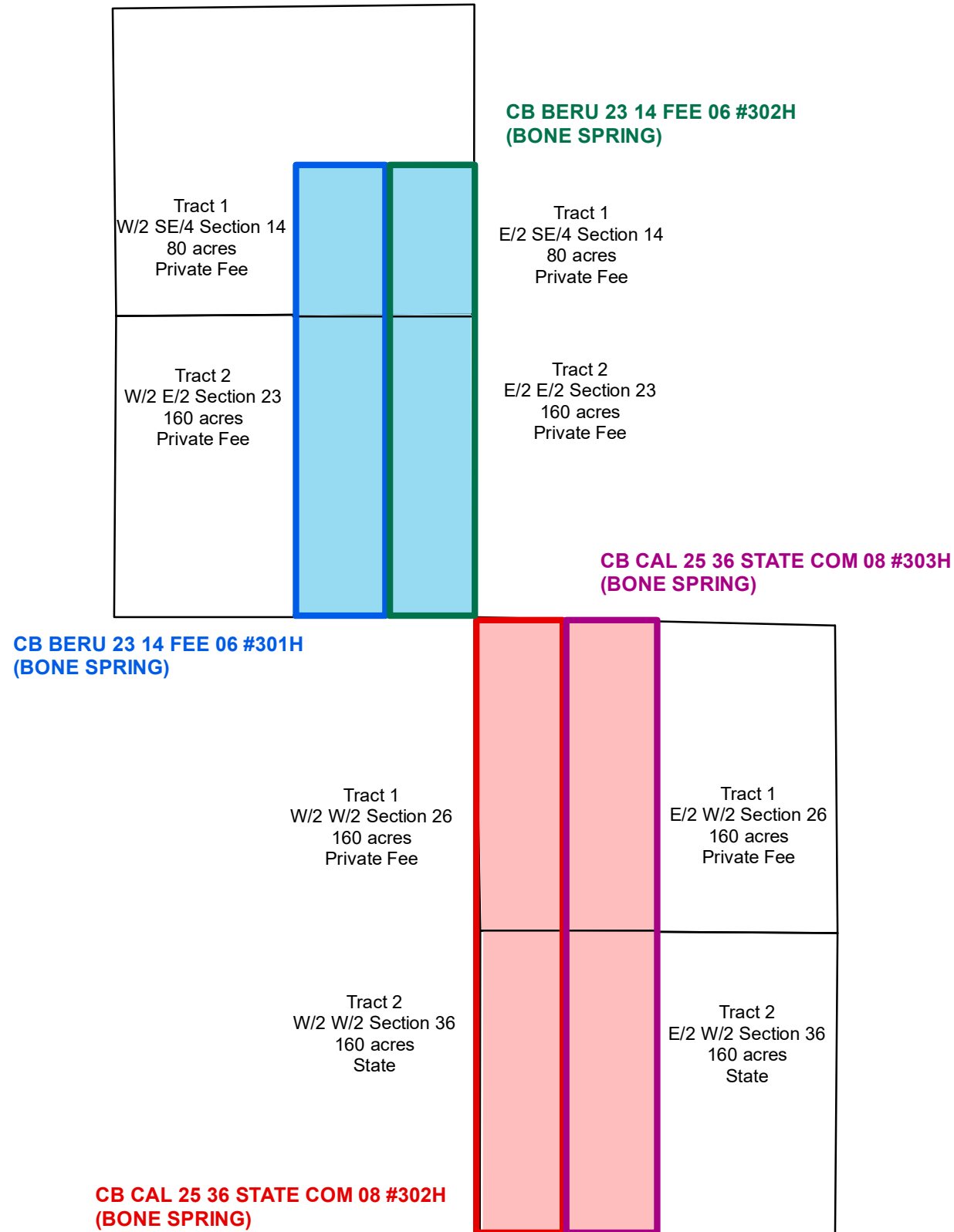

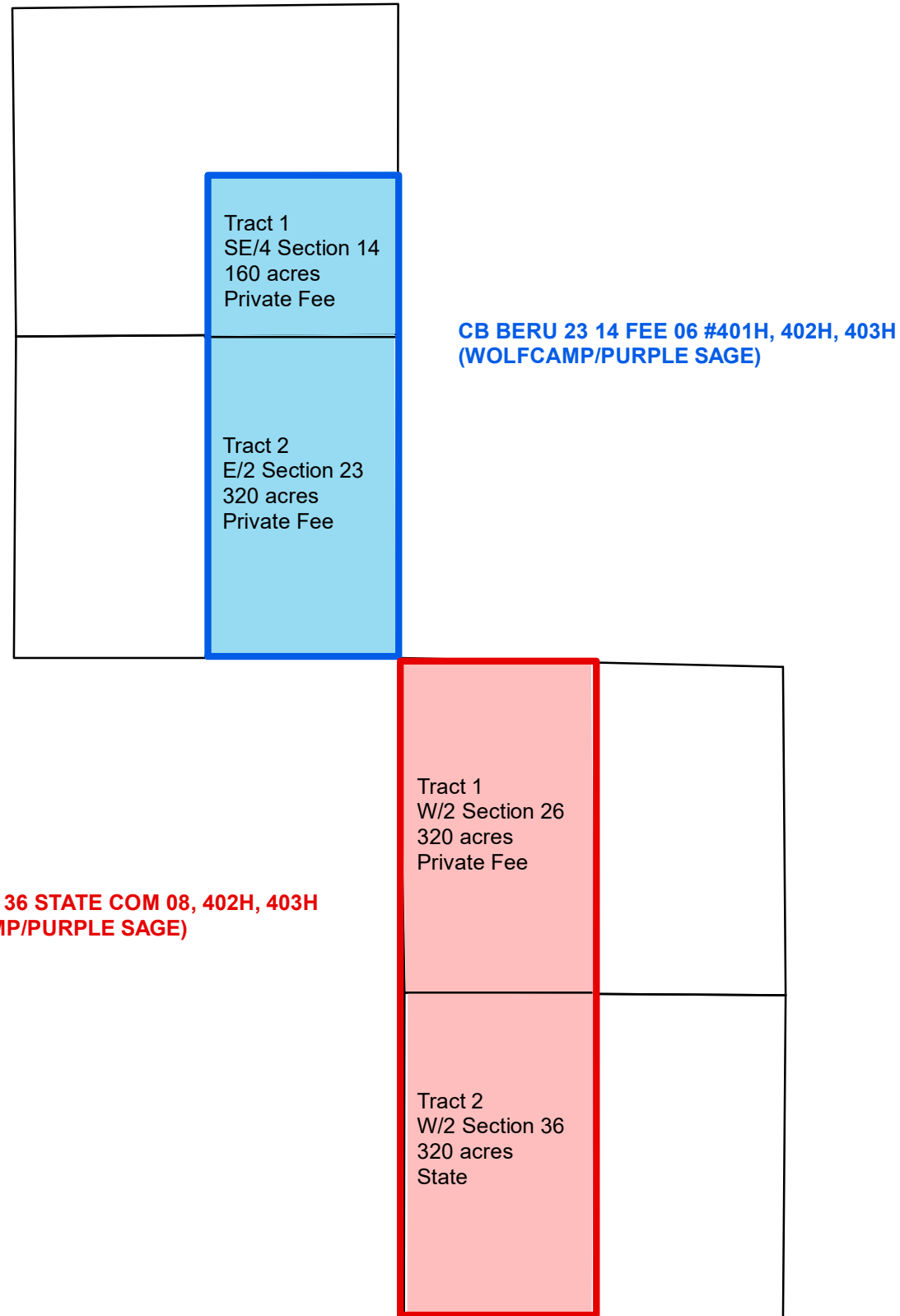
