Pursuant to NMAC 19.15.15.13, Mewbourne Oil Company applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	West Draw 5 IA Well No. 1
<u>Surface location:</u>	1440 feet FSL & 400 feet FEL
<u>Bottom hole location:</u>	330 feet FNL & 400 feet FEL
<u>Well unit (project area):</u>	E $\frac{1}{2}$ NE $\frac{1}{4}$ and NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 5, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico


The well will be drilled to a depth sufficient to test the Glorieta-Yeso formation (North Seven Rivers Glorieta-Yeso Pool). The pool is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 330 feet to a quarter-quarter section line. An APD with a Form C-102 included, is attached as **Exhibit A**.

The well will penetrate the top of the Yeso formation at an unorthodox location in Unit I, approximately 1540 feet FSL. However, the completed and perforated portion of the wellbore will be at an orthodox location, at least 1650 feet FSL. The location is due to engineering reasons: The unorthodox surface location will increase the productive length of the wellbore.

Due to the well's directional plan, the entry point in the Yeso encroaches on the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 5 (operated by applicant). However, working interest ownership is uniform in the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 5, so notice was not given to anyone in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 5. The SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 4 may be slightly affected. The only working interest owner in that tract other than applicant is Devon Energy Production Company, L.P., which has been mailed notice. **Exhibit B**.


