Reference is made to your application received on December 11, 2020.

This vertical well was drilled at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide rules, which provides for 40-acre units, with wells to be located at least 330 from the QTR/QTR line.

This well's completed interval is as close as 305 feet to the western boundary. Encroachment will impact the following tracts.


