Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Morris Boyd 10H, API Number 30-015-Pending, Property Code Pending. The 10H well is proposed to be completed in the N. Seven Rivers; Glorieta-Yeso, Pool Code 97565. The proposed wellbore is to be completed within 330’ feet of the E/2 of the E/2 of Section 26. The proposed interval is projected as follows:

Surface Hole – 954’ FSL 2084’ FEL Unit O Sec 23 T19S R25E
First Take Point – 100’ FNL 1630’ FEL Unit B Sec 26 T19S R25E
Last Take Point – 100’ FSL 1630’ FWL Unit O Sec 26 T19S R25E
Bottom Hole – 50’ FSL 1630’ FWL Unit O Sec 26 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 26, Units A, H, I and P.

Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.




