The New Mexico State Land Office (SLO) protests the SWD application of Southwest Royalties, Inc. for the Elliams #14 well, API 30-025-33479, 1650 FNL & 1980 FEL, G-34-17S-33E (OCD Administrative application SWD 2388).

SLO protests the intended location of this SWD due to its proximity to state trust lands. The proposed SWD is located less than ½ mile from the SW4SE4 of Section 27, which is state trust lands (full estate).
