Mewbourne Oil Company (OGRID No. 114744) seeks administrative approval of an unorthodox well location ("NSL") for its Glock 17/16 WOLI Fed Com #1H (API# 30-015-46746) to be completed within the Burton Flat; Wolfcamp, East (Gas) Pool (Pool Code 73480) underlying the S/2 of Section 16 and S/2 of Section 17, Township 20 South, Range 29 East, N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit "A". This is a horizontal gas well that has been drilled as follows:

Surface Location (S.L.): 2060' FSL & 230' FWL (Unit L) (Section 17)

First Perf (F.P.): 2200' FSL and 100' FWL (Unit L) (Section 17)

Last Perf (L.P.): 2200' FSL & 100' FEL (Unit I) (Section 16)

Burton Flat; Wolfcamp, East (Gas) Pool; Pool Code: 73480

Spacing Unit: S/2 of Section 16 and S/2 of Section 17, T20S, R29E, Eddy County, NM

Mewbourne Oil Company is requesting approval of a non-standard location in order to efficiently produce its interests in Section 16 and Section 17. The Glock 17/16 WOLI Fed Com #1H Well will produce from the Burton Flat; Wolfcamp, East (Gas) Pool (Pool Code 73480). There are no special pool rules for this pool, thus the setback requirements under Rule 19.15.16.15(C) of 330' apply. The completed interval for the subject well is closer than 330'


from the boundary of the spacing unit. The unorthodox location will encroach towards the W/2 of Section 15, Township 20 South, Range 29 East. A list of surrounding Wolfcamp operators is attached as Exhibit "B".

Each of these parties has been provided notice of this application by certified mail, return receipt requested, advising them that if they have an objection to the location of this Well, it must be filed with the New Mexico Oil Conservation Division within 20 days of this mailing notice.

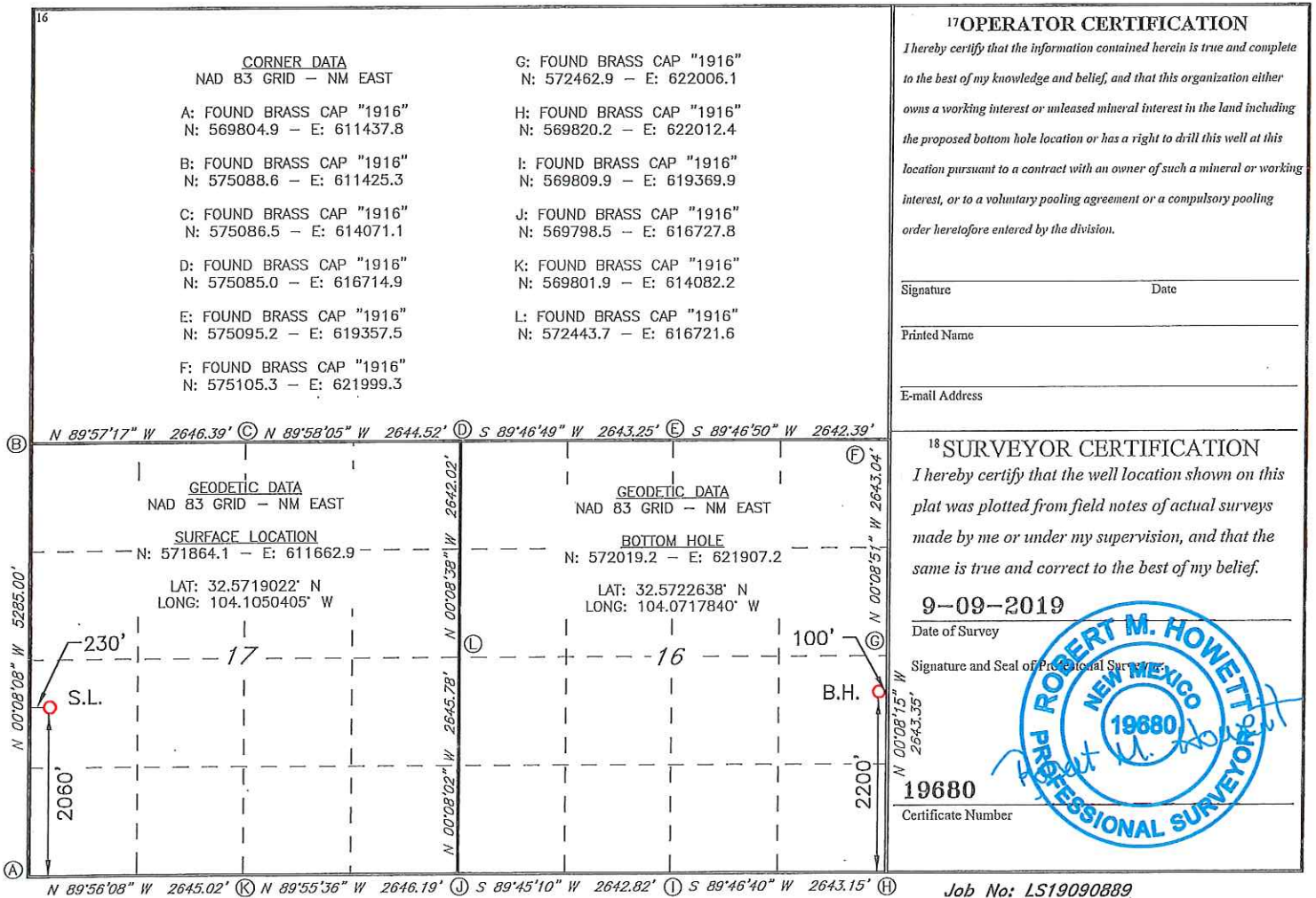

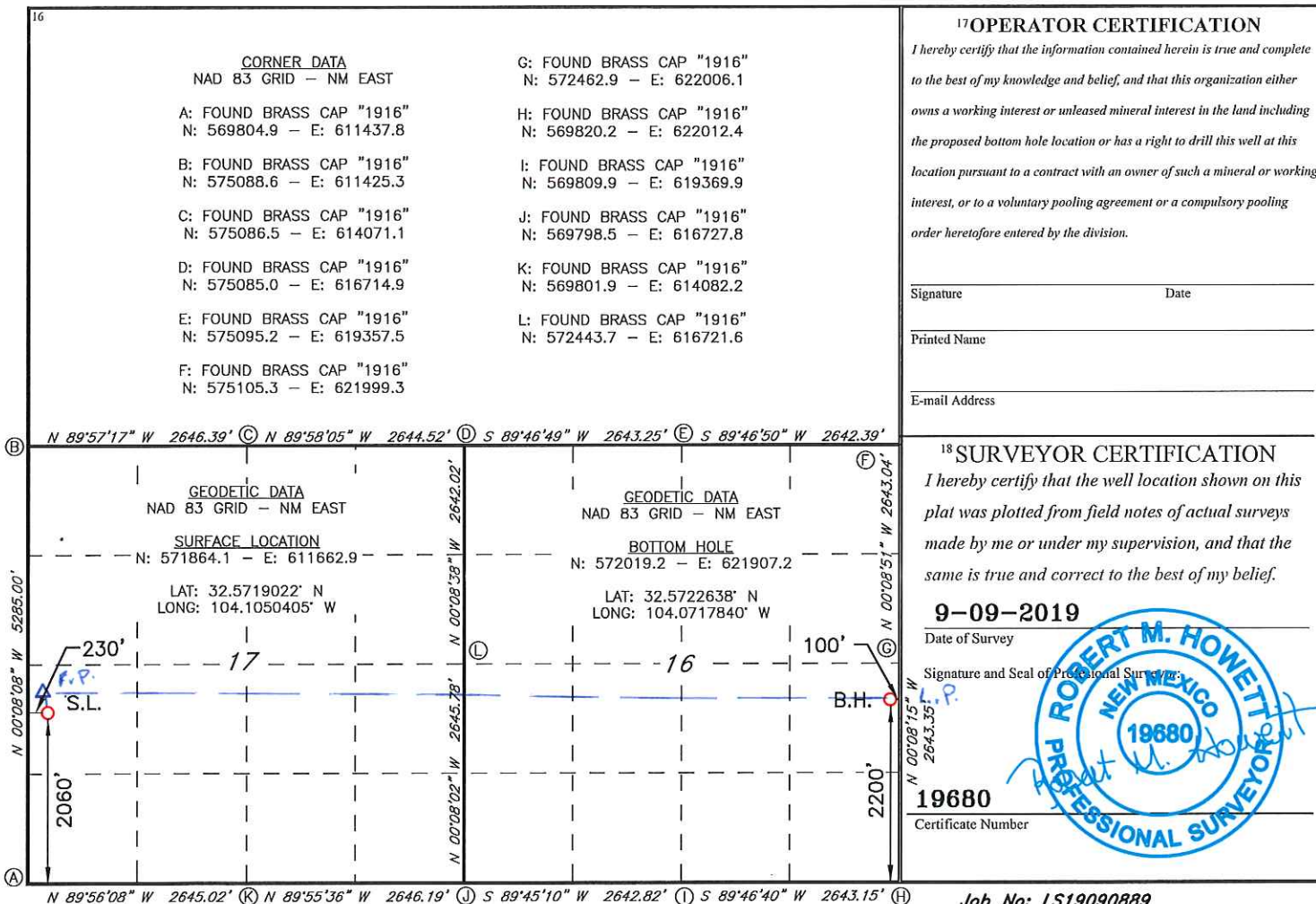
