Hi Phillip:

Mewbourne Oil Company has no objection to the granting of a second SWD permit extension for the above noted well. We are an operator in section 11 and plan to spud our first Bourbon Red HZ wells (TVD approx. 8600') in May. There are existing perforations in the DHY State B well (8870-8942') OA that need to be squeezed. If possible, due to the proximity of these squeezed perforations to our production interval, Mewbourne requests that the granting of the extension be subject to the requirement that a MIT test be performed every two years.
