Dear Ms. Sandoval,

In reference to the **Administrative Order SWD - 1752**, Rice Operating Company acknowledges the expiration of this permit date to be October 3, 2021.

Our correspondence with you today is to ask for a second extension of this SWD-1752. ROC has researched the area of review via document searches and field audits, the results being all lease ownership remains the same except for a new Operator in the Area. Please see attached Letter to the new Operator. Please note that the Well owned by the updated Operator does not penetrate the Permitted Injection interval.

We understand that the second extension is possible if drilling measures have been commenced. At this time, we have not commenced drilling, but have begun clearing Road Right of Ways to the Well Pad. This SWD-Order is 1 of 5 (3 of 5 currently drilled), which is a part of a larger project that seems to just now be coming to fruition. Contracts have "pen to the papers" as we speak.

With that said, Rice Operating Company asks that you may consider the request for a second extension to this **SWD Order 1752**. The Pandemic really put a stop and or slow down to a ton of development as you all know. With the unprecedented time, will you please consider the extension of the Administrative Order SWD -1752 as the industry seems to be trying to rebound?
