OCD Engineering staff has reviewed the referenced C-103. Would Advanced Energy Partners please correct the location discrepancy between what is reported on the C-103 and the wellbore diagram along with the elevations reported for the KB and GL on the Wellbore diagram.

With regards to accepting the modification from what was agreed upon in the order, I believe the Division was waiting on well logs with top picks to help validate the proposed top of the DMG and associated cross sections illustrating/indicating that the well was not going to penetrate the Capitan reef.

Please send the corrected and additional material before the C-103 can be accepted.
