Per the terms of FAE II's 2020 ACOI 201932 agreed upon in November 2021, FAE II is respectfully submitting the requested monthly activity update concerning the 12 wells on Exhibit A of the ACOI. Per this ACOI, FAE II has until May 15, 2022 to place all 12 wells back into compliance.

February 2022 Update:

We are pleased to report that we have returned the following wells to production:

- Baylus Cade Federal #009 (30-025-33886) was returned to production in December 2021 following a workover to repair a downhole failure.
- The State D #002 (30-025-04864) was opened up and is flowing gas at a rate of ~7 mcfd.
- Vacuum 31 #001 (30-025-32958) was swabbed during workover operations in January, resulting in 2 bbls oil and 12 bbls water. We have sent an AFE to our partners to recomplete this well in a higher zone. This work will be completed in March/April 2022.

Upcoming Plans for March 2022:

- Carlson B 27 #002 (30-025-11809): on rig schedule in March. We will reactivate well through a workover to repair downhole failure.
- Danciger #001 (30-025-27989): on rig schedule in March. We will reactivate well through a workover to repair downhole failure.
- Harrison #002 (30-025-25825): on rig schedule in March. We will reactivate well through a workover to repair downhole failure.

- State A A/C 2 #069: Is pending approval to reinstate injection authority (Case No. 22133 hearing took place on Sep 9, 2021).
- Following wells are pending approval to reinstate injection authority (Case No. 22134 hearing took place on Sep 9, 2021).
