Your proposal for remediation of a produced fluid release, referenced above, is approved with the following conditions/stipulations:

- Notify OCD District 2 office 48 hours prior to commencement of remedial activities.
- Notify OCD District 2 office 48 hours prior to obtaining any samples, where the analyses will be submitted to OCD.
- Additional samples are to be obtained, for lab analyses, in such a manner as to fully define the vertical and horizontal extent of contamination.
- Soil blending may be considered, but is not approved at this time.
- Submit a Form C-141 marked Final Report, along with a closure report, upon satisfactory completion of project.
- Project is to be completed and closure documentation submitted to OCD not later than November 1, 2011.
- Like approval from BLM, or any other regulatory authority as may be applicable.

Be advised OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
