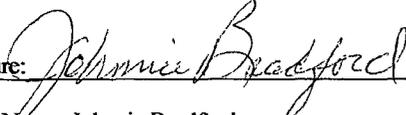
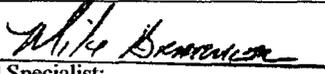
Describe Cause of Problem and Remedial Action Taken.\*

A hole developed in the steel line causing a release. The damaged section of steel line was removed and replaced with poly. All saturated soil was placed on plastic for transportation to a division approved disposal facility.

Describe Area Affected and Cleanup Action Taken.\*

Upon completion of the line repair and replacement, the affected area, approx 75' X 150' was excavated to a depth of approx 10' BGS. Soil samples were obtained and analyzed for Chlorides, TPH, and BTEX (see attached lab results). Results were presented to NM OCD's Mike Bratcher and BLM's Paul Evans requesting closure approval. Closure approval was obtained and the area was backfilled with clean material from a nearby source, contoured to match the surrounding terrain, and seeded.
