

The San Juan 31-6 Unit 224A is a Fruitland Coal and Pictured Cliffs New Drill. A cased hole neutron log will be run prior to completion to identify the Fruitland Coal and Pictured Cliffs zones. If the Fruitland Coal and Pictured Cliffs horizons can be isolated, a separator test will be performed and the allocation will be assigned with results using the subtraction method applied to the rate. In the event that the Fruitland Coal, Fruitland Sand and Pictured Cliffs can not be tested separately, a volumetric calculation will be performed to determine the allocation percentages between the Fruitland Coal and Pictured Cliffs. All documentation will be submitted to the Aztec NMOCD office.




