Re: Application of Williams Production Company for Administrative Approval of the Simultaneous Dedication of the East-Half of Section 30, Township 31 North, Range 4 West, N.M.P.M., Rio Arriba County, New Mexico to its proposed Rosa Unit Well No. 063 and the existing Rosa Unit Well No. 063A

Dear Ms. Bailey:

Williams Production Company is the operator of a 320-acre spacing unit in the Basin Fruitland Coal Pool (**Pool Code 71629**) comprised of the east-half of Section 30, Township 31 North, Range 4 West, N.M.P.M., Rio Arriba County, New Mexico. This spacing unit is dedicated to Williams' Rosa Unit Well No. 063A which has been directionally drilled and produces from the Fruitland Coal formation.

Williams seeks administrative approval of the simultaneous dedication of this 320-acre spacing unit to the following two gas wells: (Amended)

- A. the **Rosa Unit Well No. 063A (API No. 30-039-29776)** directionally drilled from a surface location 1840 feet from the South line and 1430 feet from the East line of said Section 30 to a bottom hole location of 1650 feet from the South line and 990 feet from the East line of Section 30; and
- B. the proposed **Rosa Unit Well No. 063 (API No. 30-039-21395)** to be horizontally drilled from a surface location 1626 feet from the North line and 1884 feet from the East line to a proposed end point or bottomhole location 700 feet from the South line and 2528 feet from the East line of

said Section 30.

Rosa Unit Well No. 063A is at a standard location in the Fruitland Coal formation pursuant to the Special Rules and Regulations for the Basin-Fruitland Coal Gas Pool. Williams now intends to horizontally drill and complete its proposed Rosa Unit Well No.063 to be drilled to the targeted subsurface end-point or bottomhole location 700 feet from the South line and 2528 feet from the East line (Unit O) of Section 30. Williams proposes to drill this well in compliance with the set-back requirements of the Special Rules and Regulations for the Basin-Fruitland Coal Gas Pool as amended by NMOCD order number R-13200.

Attached hereto as **Exhibit A** is a copy of Division Form C-102 for this well that shows the proposed surface and bottomhole location of the well.


Exhibit B is a map of offset operators around the spacing unit in Section 30, T31N - R4W. Williams is the operator of all offsetting spacing units within Rosa Unit as well as in Section 32, T32N, R4W.

Williams has mailed, via USPS Certified Mail, Notice to the offset working interest owners that this application has been submitted. A copy of the List of Offset Owners as well as the Notice is attached hereto as **Exhibit C**.

The simultaneous dedication of the East-Half of said Section 30 to the Rosa Unit Well No. 063A and Rosa Unit Well No. 063 will afford Williams the opportunity to efficiently produce the Fruitland Coal formation under this spacing unit. Williams' proposed simultaneous dedication of these wells does not exceed the number of wells allowed by Division Rule for this spacing unit.




