Dear Ms. Bailey:

On August 25, 2011, we submitted a request on behalf of Nearburg Producing Company to amend NSL Order 6367 to change the unorthodox bottom hole location for the Howenstine 12 Well No. 1. Nearburg now wishes to change the bottom hole location again, this time to the following: 350' FNL and 1540' FEL. The reason for the second amended location is based on further refinement of recently obtained seismic data. As before, the surface location remains unchanged.

The second amendment will reduce the encroachment even further and moves the well's bottom hole location closer to a standard location under the pool rules for the Shipp-Strawn Oil Pool (wells to be located within 150 feet of the center of a governmental quarter-quarter section with 80-acre units). All other points supporting Nearburg's August 25, 2011 request to amend NSL 6367 continue to apply. Again, no further notification is indicated under the Division's rules (see Rule 19.15.4.12A[2][b]).
