Pursuant to Division Rule 19.15.12.10, Apache Corporation ("Apache") respectfully requests administrative approval to surface commingle North Eunice Blinebry-Tubb-Drinkard Pool (22900) production originating from thirteen (13) wells within Apache's East Blinebry Drinkard Unit Waterflood Project with Hare-Simpson Pool (29830) production originating from Apache's Lockhart B-12 Well No. 5. Production from these wells will be processed and stored at the East Blinebry Drinkard Unit Satellite Tank Battery No. 2 located on Federal Lease No. LC-032096B within the SE/4 NW/4 of Section 12, Township 21 South, Range 37 East, NMPM.

The East Blinebry Drinkard Unit Waterflood Project comprises approximately 2,080 acres of Federal and fee lands. Production from secondary recovery operations within the unit is stored at several different satellite tank batteries located within the Unit Area. Satellite Tank Battery No. 2 currently receives unit production from the East Blinebry Drinkard Unit Wells No. 28, 33, 35, 77, 29, 106, 98, 91, 112, 122, 95, 74 and 113. Apache proposes to commingle Hare-Simpson Pool production from the Lockhart B-12 Well No. 5 at the East Blinebry Drinkard Unit Satellite Tank Battery No. 2.

Production from the Lockhart B-12 No. 5 currently averages approximately 1 BOPD and 15 MCFGD. Due to the low production from this well, it would be uneconomic to construct a tank battery to process and store this well's production. Total production from the other thirteen East Blinebry Drinkard Unit wells going into this tank battery averages approximately 272 BOPD and 967 MCFGD. Due to similar fluid characteristics, no decrease in the value of production from these wells will occur as a result of commingling.



Production to each of the wells to be commingled will be allocated on the basis of well tests conducted on a monthly basis. Apache believes that this method of allocation, given the extreme marginal nature of the Lockhart B-12 No. 5, will adequately protect the correlative rights of all interest owners, and will allow Apache to continue to economically produce the Lockhart B-12 No. 5. Total production from all wells commingled at the East Blinebry Drinkard Unit Satellite Tank Battery No. 2 will be metered prior to being sold.

Apache is providing notice of this application by certified mail to all working, royalty and overriding royalty interest owners within the East Blinebry Drinkard Unit and Lockhart B-12 Federal Lease. Notice is also being provided to the Bureau of Land Management.

Attached is a Form C-107-B, facility schematic diagram, map showing the well locations and tank battery, a list of wells to be commingled, notice letter and a list of parties to whom notice has been sent.
