RE: Application of Energen Resources Corporation for Administrative Approval of the Simultaneous Dedication of the North-Half of Section 10, Township 32 North, Range 5 West, N.M.P. M., Rio Arriba County, New Mexico to its existing Carracas 10 A #8 Well and the Carracas 10 A # 5H Well.

Dear Ms. Bailey:

Energen Resources Corporation is the operator of a 236.72 acre spacing unit in the Basin Fruitland Coal Pool (**Pool Code 71629**) comprised of the north-half of Section 10, Township 32 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico. This spacing unit is dedicated to Energen's Carracas 10 A # 8 which was vertically drilled and is capable of production from the Fruitland Coal formation.

Energen seeks administrative approval of the simultaneous dedication of this 236.72 acre spacing unit to the following two gas wells:

A. the **Carracas 10 A # 8 well (API No. 30-039-26420)** vertically drilled from a surface location 800' FNL and 540' FWL of Section 31 pursuant to Order NSP-1597 and

B. the horizontally drilled **Carracas 10 A # 5H well (API No. 30-039-30135)** which was horizontally drilled from a surface location 755' FNL and 820' FEL of Section 10 to a bottom hole location 944' FNL and 1,587' FWL of Section 10. The entry point was at 835' FNL and 1,598' FEL of Section 30.

Neither well violates the existing set back requirements for these wells.

Attached hereto for each well is a copy of Division Form C-102 for these wells that show the surface and bottom hole locations of each well. In addition also enclosed is a map of the offset operators of all offsetting spacing units. Energen Resources is the operator of all offsetting spacing units and owns 100% of the working interest in all offsetting spacing units with the Exception of Section 9-T32N-R5W which is unleased acreage owned by the Bureau of Land Management.

Energen has mailed, via USPS Certified Mail, Notice to the Affected Parties that this application has been submitted. A copy of the Notice to the Affected Parties is also attached.

The simultaneous dedication of the North-Half of said Section 10 to the Carracas 10 A # 8 and the Carracas 10 A # 5H wells will afford Energen the opportunity to efficiently produce the Fruitland Coal formation under this spacing unit. Energen's proposed simultaneous dedication of these wells does not exceed the number of wells allowed by division Rule for this spacing unit.






