Re: Downhole Commingling, Gas-Gas, YPC - SRC KZ State No. 6
Unit C, Sec 1-T19S-R24E, Eddy County

Yates Petroleum Corporation seeks Administrative Approval for dual completion and downhole commingling in subject well to permit sustained flow from two weak zones, the Penasco Draw-Permo Penn and the Penasco Draw-Morrow. The ownership of the zones to be commingled are the same.

A plat of the area showing the acreage dedicated to the well and the ownership of all offsetting leases is attached hereto.

A current C-116 for the Morrow completion and the C-116 for the Canyon completion prior to shut in in May 1988, are attached hereto.

Production decline curves for both zones are submitted.

The shut-in tubing pressure for the Canyon zone was 525 psig before the zone was isolated, while the shut-in tubing pressure for the Morrow zone is 470 psig.

Neither zone produces any liquids in a quantity that can be measured. The Morrow sand which is susceptible to damage from liquids is protected with a standing valve.

The Morrow completion flows 12-13 MCFPD on sustained flow which economically is just about break-even. The Canyon completion has much better permeability and has a reserve of about 259 MMCF to the economic limit of 370 MCF per month.

By commingling the Morrow and Canyon, total reserves would be extended by 14 MMCF. Commingling can be accomplished by opening the sliding sleeve in the tubing below the Canyon completion, diagram of wellbore is attached.

There will be no loss in value of produced gas by commingling since the wellhead prices for Canyon and Morrow are the same.

By commingling, the Canyon reserves become 260 MMCF and the Morrow is extended to 13 MMCF. It is suggested that commingled production be prorated as follows(formula attached):

Penasco Draw Permo-Penn	99.5 percent
Penasco Draw Morrow	0.5 percent

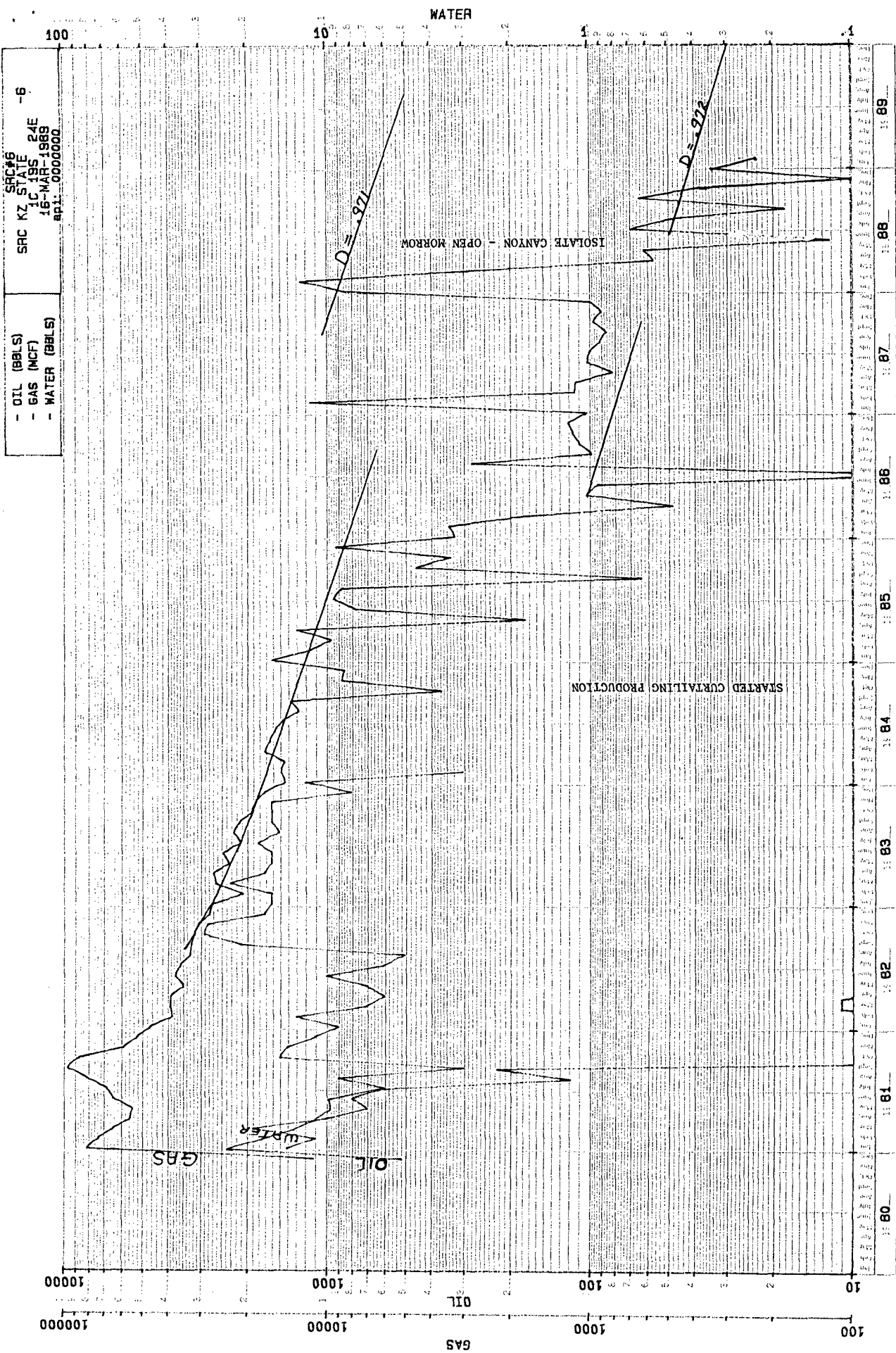
