Please submit to the OCD a final plugging report for groundwater monitoring wells (MW-2, MW-3, MW-4, MW-5, MW-6, MW-8, and MW-9) at the site within 90 days of receipt of this notice.

The above-referenced report, submitted in accordance with 19.15.29 NMAC (Rule 29; formally, Rule 116), indicates that Plains has met the requirements of 19.15.29 NMAC; therefore, the OCD approves the report and hereby notifies you that the remediation plan (1R-102) is terminated in accordance with 19.15.29 NMAC.
