



Describe Cause of Problem and Remedial Action Taken. (If water spilled, give Chloride content)\*  
**A DCPM pipeline (M-28) was struck by a contractor just west of Duval Shaft Road while the contractor was mining caliche from a State/BLM owned pit at that location. The resulting release from the line strike generated ~15 bbls of oil sprayed over 1.5 to 2 acres and ~420 Mscf of natural gas released to the atmosphere.**  
**The pipeline segment was immediately isolated from service by DCPM field personnel. The affected area was evaluated and a remediation contractor consulted to provide clean up services. The gongie in the pipeline was repaired as safely and expeditiously as possible by contracted Roustabout crews.**

Describe Area Affected, Dimensions, and Cleanup Action Taken.\*  
**Hungry Horse Environmental will evaluate the site and submit a work plan for approval before remediation is to begin.**

**Site Background Info**

This affected area is between Hobbs and Carlsbad on CR250/Grubbs Road approximately 1 mile east of Highway 360. The remediation is the result of a line strike by a contractor that caused an unplanned release of fluid from the pipeline owned by DCP Midstream. The release point is at the northeast corner of a caliche pit. The north half of the pit, as well as the affected area, is owned by the State of New Mexico.

The natural contour of the land is a gradual slope to the west. There are two arroyos that run east/west on the north side of the pit. These arroyos are approximately 5'-7' deep. The area consists mainly of native grasses, yucca plants, and mesquite bushes. Based upon the Eddy County Depth to Groundwater Map, depth to ground water is 100'-200'. There are no known water wells or surface bodies of water within 1000' of this location. Thus, this site is given a Site Ranking Score of 0.

**Work Conducted to Date**

Upon notification of the line strike, the line was shut in and immediately repaired. Due to the location of the line in relation to the stockpile of the pit, much of the released liquid was absorbed into the loose stockpiled overburden. Thus recovery of released liquid by vacuum truck was not possible. A site assessment was conducted and initial soil samples were obtained (see attachments) to determine the contents of the line and to aid in developing a remediation work plan.

**Proposed Work Plan**

The goal of this proposal is to thoroughly remediate the affected areas by causing minimal amount damage to the existing terrain. This goal will be accomplished by the following steps.


- 1) Using a pressure washer, all mesquite bushes and any other vegetation taller than the native grasses will be thoroughly washed with a mixture of freshwater and a biodegradable soap.
- 2) The affected areas on the walls and bottom of the two arroyos (see attached sketch) will be treated with a heavy application of MicroBlaze.
- 3) The area to the north of the pit that received the over-spray will be heavily disked allowing the minimal surface contaminants to be blended with clean soil.
- 4) The area in the vicinity of the where the line strike occurred, will be excavated to remove the heaviest concentrations of saturated soil. The excavated material will be transported to a division approved facility for disposal.
- 5) Upon removal of the saturated soil, additional soil samples will be obtained and analyzed for Chlorides/TPH/BTEX. Lab results will be presented to NM OCD's Mike Bratcher for discussion of the possibility of blending the remaining contaminants with the stockpile of overburden material on the north side of the pit.
- 6) When moisture conditions are favorable for re-growth, the area to the north that was heavily disked will be re-seeded with a NM State Land Office seed mixture and lightly disked.

Thanks for your help and I look forward to once again working with all involved.



Your proposal for remediation of a produced fluid release, referenced above, is approved with the following conditions/stipulations:

- Notify OCD District 2 office 48 hours prior to commencement of remedial operations.
- Notify OCD District 2 office 48 hours prior to obtaining any samples where the analyses will be submitted to OCD.
- Obtain representative samples, for lab analyses, from the playa area at the base of hill where affected arroyos drain. Samples are to be obtained prior to commencement of washing activities. This data will serve as baseline/background information for future sampling from this area. The object being, to insure contaminants are not being washed down during precipitation events.
- Soil blending will be considered, based on analytical data, but is not approved at this time.
