The commingled gas production shall be measured and sold at the Enterprise Central Delivery Point (CDP) meter located in the Northeast quarter of Section 24, Township 22 South, Range 25 East, NMPM, Eddy County, New Mexico. Gas production from the wells is approved for off lease measurement and sales.


Gas production from the wells shall be measured continuously with allocation meters before commingling with gas production from other wells. The allocation meters shall be calibrated monthly.

Liquid production shall not be commingled.

The producer/operator shall notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.
