


Jicarilla Apache Energy Corporation, JAECO, is writing to request your respective administrative approvals for an Unorthodox Well Location for the JVA 4B Blanco-Mesaverde well staked at 446' FNL & 2245' FEL, Sec 20, T27N, R2W, NMPM, Rio Arriba County, New Mexico. JAECO had the well re-staked to this location at the request of the Jicarilla Apache Tribe Oil & Gas Administration, during the onsite conducted on April 28, 2004, to avoid elk and deer habitat, adverse topography and pine trees. The location, access road and pipeline ROW have been arched by Velarde Energy Service.

JAECO is the sole division-designated operator of Section 20, T27N, R2W and all adjoining spacing units. Since there are no other persons owning interests in the adjoining spacing units, there are no affected persons requiring notice as defined in Rule 1207.A(2).

Attached is NMOCD form C-102 and a plat showing: the spacing unit, the proposed unorthodox well location and the adjoining spacing units and wells.


