Request for Unorthodox Location

Dear David Brooks:

ConocoPhillips Company respectfully request an unorthodox location exception to drill the Ruby Federal #6. The well is located 236' from the west line of the 40 acre unit letter M, of Section 17, Township 17S, Range 32 E, Lea County NM. During the onsite inspection with the BLM, this location was found to be the only suitable position due to potential sand dune lizard habitat that would allow us to reach our targeted production zone. ConocoPhillips is 100% lessee and 100% working interest owner of the Ruby federal lease. The granting of this exception will prevent waste and minimize surface disturbance of habitat deemed critical by the BLM.
