

An approximate area of 50' x 40' inside battery. Remaining oil picked up by vacuum truck inside the battery. Impacted soils were excavated and hauled to an NMOCD approved facility. Initial vertical and horizontal delineation samples with in the impacted area will be taken and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL, a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 166', T11S-R26E, NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
