Resaca Operating Company respectfully requests administrative approval to downhole commingle the Jalmat and the Langlie Mattix Pools within the subject wellbores. Currently, the wells have been approved for Re-Entry. Notification of offset operators is not an issue given the fact that Resaca offsets all of the wells.

Downhole Commingling these wells will provide a more economical and efficient means of production. It will allow complete development of the productive capacity on the subject lease by allowing both pools to be artificially lifted simultaneously. This will extend the life of both completions, thereby preventing waste.

The subject wells meet all of the requirements of Rule 303 (C). All produced fluids from other downhole commingled wells have entered a common production facility with no fluid compatibility problems.

Resaca also requests the allocation of production for each pool be deferred until a stabilized production rate is established. Production will then be allocated to the Jalmat and Langlie Mattix Pools. Tests for both pools will be reported on the Subsequent Sundry Reports. Drill new hole to new TD @ 3730'. Downhole commingle Jalmat and Langlie Mattix Pools; Perfs 3006'-3468' (OH 3485'-3730'). Put well on production.

- 1.) Remove dry hole marker; MIRU Pulling Unit & Reverse Unit; Closed Loop System will be used.
- 2.) NU & test 2M BOP System.
- 3.) PU 6 1/4" Bit on 2 3/8" production tubing & drill out cement plugs @ surface-300', 995'-1200'.
- 4.) Tag top of liner @ 2916'; circulate well clean; POOH & LD 6 1/4" Bit.
- 5.) PU 3 7/8" bit on 2 3/8" production tubing, drill out cement plug @ 2545'-2950'; CIBP @ 2950'.
- 6.) Clean out well to 3572' (current TD); drill new hole to 3730'; circulate well clean; POOH & LD 3 7/8" Bit.
- 7.) PU 4 1/2" Tension Packer & RIH to 2950'. Set Packer @ 2950' & test casing to 500 psi. POOH & LD Packer.
- 8.) Frac well & flow back.
- 9.) PU 4 1/2" TAC & RIH w/ 2 3/8" production tubing. Space out & set TAC. Land tubing.
- 10.) ND BOPs & NU Pumping Tee.
- 11.) NU rod stripper. PU & RIH w/ downhole pump & rods. Seat pump. Hang off rods. ND rod stripper & pack off rods.




