ORDER

IT IS HEREBY ORDERED that the following specifications shall be followed for the construction of oil, gas, mineral and test wells in artesian basins.

The water protection casing string (also designated as the second or intermediate string) shall be landed into the formation below all known artesian aquifers. Sufficient cement shall be used to obtain circulation to the surface. If surface casing is used, said casing shall not be removed until after cementing of the water protection string has been completed. When circulation to the surface on the water protection string is not obtained, the operator shall run a temperature survey to insure that the cement has circulated to a point well above all artesian aquifer formations. If the temperature survey shows the top of the cement to be in a shallow water zone, the operator, under the direction of a representative of the United States Geological Survey, New Mexico Oil Conservation Commission or the State Engineer, shall place cement to the surface behind the water protection string or circulate cement to the surface on the oil production casing string. Additives of a pozzolanic nature may be used above the casing shoe, but, shall not exceed 50% by volume. The addition of calcium chloride and/or gel may be required, but shall not in any case exceed 2% each by weight. A sufficient amount of cement without additives shall be used to allow neat cement to seal the casing shoe, and rise a minimum of 50 feet above the shoe between the casing and hole. Cement shall be allowed to set a minimum of 48 hours before drilling is resumed. Sealing off of the formations shall be checked by a method approved by the United States Geological Survey, New Mexico Oil Conservation Commission or the State Engineer's Office.

The oil production string or strings shall be landed and cemented as specified by the United States Geological Survey (Oil and Gas Branch) or the New Mexico Oil Conservation Commission.

The preceding casing, cementing and testing program shall be witnessed by an authorized representative of the United States Geological Survey, New Mexico Oil Conservation Commission or the State Engineer's Office.

MEMORANDUM:

TO: All Operators in the Hobbs, Bowers and Byers-Queen Pools

FROM: A. L. PORTER, Jr., Secretary-Director

SUBJECT: Protection of Fresh Water

1. Prior to January 1, 1958, all open bradenheads must be closed in a permanent manner with bleeder lines brought to the surface with a valve attached which should remain open at all times, Form C-103, original and two copies, must be filed with the Hobbs Commission Office upon completion of the work.

2. Beginning January 1, 1958, casing leak surveys will be conducted on a quarterly basis. The results of such tests must be filed by the 15th of each of the following months on a form prescribed by the Commission: January, April, July, and October. (The first report for 1958 will be due April 15, 1958.) The tests taken during the quarter beginning April 1, will be witnessed by a Commission representative as per published schedule. Forms for the reporting of the results of surveys will be available at the Hobbs Commission Office.

3. No oil field brines shall be disposed of in earthen pits in the Hobbs Pool area after completion of the Hobbs Pool Salt Water Disposal System.

4. No waste oil nor basic sediment shall be disposed of in earthen pits in the Hobbs Pool Area.

5. All operators are urged to institute measures for the prevention of both internal and external corrosion.

To: All operators in the Hobbs, Bowers, Byers Queen Gas and Hobbs Drinkard Pools.

In accordance with the memorandum issued by the District Engineer pertaining to casing pressure tests in the above-named pools, the following wells will be readied for an annual inspection in the manner and on the date as herein outlined.

1. All wells must be shut in 24 hours before inspection will be witnessed
2. All cellars will be dug in a manner to expose the outlets of all bradenheads from the first string of pipe cemented in the well and to expose all subsequent heads to and including the tubing head, unless a C-103 has been filed, indicating satisfactory connections below the ground level and with proper identification above ground level.
3. One opening from all bradenheads will be connected above the surface of the ground with a second valve. The second valve must be closed in compliance with paragraph number one.
4. The operator must furnish connections and personnel who will assist in the opening of valves. Pressure gauges to record pressures should also be furnished, if possible.
5. The Proration Manager will be notified of a well that has failed to meet the requirement of preparation as outlined on the date-time schedule, and such well will be immediately removed from the proration schedule. The loss of allowable will begin from the date of the bradenhead inspection of the well.
6. If, due to unusual mechanical difficulties or workover operations, a particular well cannot be made ready at the time set forth on the schedule, its test date may be delayed after inspection of the conditions by the Commission representative. The Commission should be notified at least 48 hours prior to test time for well or wells that require such delays.
7. The Commission expects company personnel to be present at the meeting place on the date and time indicated on the attached schedule. If for any reason the operator or his representative cannot be present, the Commission must be notified in advance.

In every case, the Commission representative will meet the company personnel at the place and time shown on the schedule and proceed to all listed wells in logical order.
