Do you see any MIT, Surface or other Compliance issues that would prevent this well from undergoing a CHANGE OF OPERATOR from [I&W Inc.] to ???

Obviously the new operator would first need to be in compliance with Rule 5.9 – and I don't know who the new operator will be.

Dorothy asked me about this - as is the custom on proposed Change of Operators.

I looked it over and see that April 2010 was the last reported disposal – so it will need a request to extend the inactive period very soon or the permit SWD-318 will expire.

There is a nearby gas well in the Empire;Penn Gas Pool (which is downhole from the actual disposal interval) operated by ConocoPhillips, but I don't see any effect on this well from the meager records I have to review.

I looked over the subject well file to determine if the disposal interval was as permitted in SWD-318 and it seems to be – unless something was not reported.

So I don't have a problem with it, but passing the review on to you guys.
