



All, this email is to inform you of a Reportable leak that Oxy Permian had at the Riverbend Federal B-11. Total release was 151 bbls of oil, with 73 recovered. The leak was due to failure of a Victaulic clamp at the circulating pump. Battery is located in Section 23, Township 24s, and Range 29E of Eddy County. Oxy will be performing some initial clean up of the surface soils and gathering soil samples to be tested for impact in the near future. A C-141 will follow.
