Describe Cause of Problem and Remedial Action Taken.*

The alarm system failed at the tank battery causing the produced water tank to overflow. Electricians have corrected the problem.

Describe Area Affected and Cleanup Action Taken.*

Initially 160bbbs were released into the lined dike of the Foster Eddy Tank Battery. Due to the volume of the release, some of the fluid was able to reach a portion of the tank battery that is not lined with 40mil plastic. Tetra Tech will take soils samples of the spill area in the unlined portion of the tank battery to delineate any possible contamination from the release. We will submit a work plan to the NMOCD/BLM for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. Please see below the detailed description of a reportable release:

On 3-13-12 at approximately 7:00pm, an oil spill was discovered at the Foster Eddy Battery. 160bbbls was released into the dike, with all 160bbbls being recovered. 150bbbls remained in the lined portion of the dike. 10bbbls went to the unlined portion creating a contamination area of 20 X 50. The contaminated soil will be removed and the gravel within the lined portion will be cleaned / replaced as necessary. The released was caused by higher than usual pressures on the water system combined with an alarm system failure. The alarm was corrected last night and the battery returned to service. We will follow up with a C-141 initial Report.
