Pursuant to Division Rule 104.D(2), Chi Energy, Inc. applies for approval of a non-standard gas spacing and proration unit for the following well:

Well:

Mesa Oro "34" State Well No. 1

Well unit:

SE1/4 of Section 34, Township 21 South, Range 26 East, N.M.P.M.,

Eddy County, New Mexico

The well will be drilled to a depth sufficient to test the Strawn and Morrow formations (Undesignated Happy Valley-Strawn Gas Pool and Undesignated Happy Valley-Morrow Gas Pool). Applicant requests non-standard unit approval in both formations. The pools are spaced on statewide rules, with 320 acre spacing, and wells to be located no closer than 660 feet to a quarter section line nor closer than 10 feet to a quarter-quarter section line.

Attached as Exhibit A is a land plat of part of 21S-26E. The NE¼ of Section 34 is unleased federal land. Under (federal) Public Land Order 5115, the NE¼ of Section 34 is not open for mineral leasing (the surface is part of the Living Desert State Park). In addition, the W½ of Section is dedicated, in the Strawn and Morrow formations, to the State "Q" Com. Well No. 1, located in the NW¼SW¼ of Section 34. Therefore, applicant cannot form a standard S½ well unit.


