This area contains all or portions of Federal Leases No. NM-4465, NM-10561, NM-10758, NM-10875, NM-16057, NM-16765, NM-19163, NM-19403, NM-21463, NM-21465, NM-55114, NM-56318, NM-58896, NM-63321, NM-70298, NM-70299, NM-70300, NM-71716, NM-76870, all or portions of State Leases No. E-3555, E-6714-8, LG-3045-1 and VA-1696, and three (3) fee leases that comprise all or portions of Sections 13 and 24, Township 30 North, Range 15 West, and Section 7, Township 30 North, Range 14 West, NMPM, San Juan County, New Mexico.

This area currently contains forty-three wells that are either singly completed or downhole commingled within one or more of the pools described above. With the exception of one well, the Kelly Well No. 1, located in the SE/4 SE/4 of Section 25, Township 30 North, Range 15 West, NMPM, which is currently operated by Redwolf Production Inc., all wells within the area are operated by Dugan Production Corporation.

Dugan Production Company now requests to amend Order No. PLC-187 to add Fee Leases, Federal Leases NM-113433, NM-113973, Harper Hill Fruitland Sand Gas Pool (78160), and twenty-five (25) wells to the Turk's Toast Gas Gathering System shown in **Exhibit A** attached to this Order. Dugan also requests that further additions to the Turk's Toast Gas Gathering System require notice to only those interest owners in the leases, pools, and wells to be added

**Dugan's request to add the leases, pools and wells is hereby approved, and further additions to the Turk's Toast Gas Gathering System shall require notice to only those interest owners in the leases, pools, and wells to be added.**

Production shall be allocated by metering the gas production from each of the wells within the Turk's Toast Gas Gathering System Area utilizing individual allocation meters. Gas production shall then be commingled and transported to gas sales meter (El Paso Meter No. 14102) located in the SE/4 NE/4 of Section 6, Township 29 North, Range 14 West, NMPM. Production shall be allocated back to each well utilizing allocation and sales meter volume data, and shall be determined in accordance with the formula set forth within the application to commingle.

**No liquids shall be commingled within the Turk's Toast Gas Gathering System.**


NOTE: This installation shall be installed and operated in accordance with the applicable provisions of the Division Rules and Regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: The operator shall notify the Aztec district office of the Division upon commencement of commingling operations.
