The well was shut in and the stuffing box packing was replaced.

Approximately 7250 sq.ft. of caliche well pad was affected by the release, all of the fluid had soaked into the ground upon discovery; a backhoe was used to scrape up the heavily saturated soil and was stockpiled on-site. The remediation will follow the NMOCD and BLM spill guidelines.
