Dear Ms. Bailey:

Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed D State No. 86. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed D State No. 86 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the NW/4 SE/4 of Section 34. This unit is currently dedicated to Apache's: i) proposed D State No. 85 (API No. 30-015-40441) located at an unorthodox well location 2405 feet from the South line and 2250 feet from the East line; ii) proposed D State No. 87 (API No. 30-015-40232) located at an unorthodox well location 1555 feet from the South line and 2290 feet from the East line; and iii) proposed D State No. 88 (API No. 30-015-40233) located at an unorthodox location 1460 feet from the South line and 1755 feet from the East line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid an existing well pad.

The two affected offset tracts are the SW/4 NE/4 of Section 34, which is operated by Occidental Permian Ltd. in the Artesia-Glorieta-Yeso Pool, and the SE/4 NE/4 of Section 34, which is operated by COG Operating, LLC in the Artesia Glorieta-Yeso Pool.

Notice of this application is being provided by certified mail to Occidental Permian Ltd. and COG Operating, LLC.

Attached is a Form C-102 showing the proposed well, spacing unit, other proposed wells in the spacing unit and the affected offset acreage. Also attached is a vicinity map, and an offset operator notice letter.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the NW/4 SE/4 of Section 34 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.




