Dear Ms. Gregston,

Talon/LPE is sending the analytical results for the soil samples collected from the excavated area located on the Enterprise Products right-of-way. Hydrocarbon from the Devon Energy Corp. Hackberry Fed. 18 No.1 release flowed onto the right-of-way and then pooled on a two track road. The hydrocarbon impacted soils from the release were excavated and then hauled to CRI for disposal. The work plan for the correction of the Hackberry 18 Fed. No.1 release is being constructed and will be submitted to the BLM and NMOCD for regulatory approval. Due to a safety issue, Devon Energy Corp. is requesting approval to proceed with backfilling the excavated area location on the Enterprise right-of-way using new soil transported to location.
