Dear Mr. Henry:

The New Mexico Oil Conservation Division (OCD) has received the Rice Operating Company's (ROC) the Soil Closure Request for the Remediation Plan (1R-420) for the Texaco Skelly 'F' Release Site, dated May 2012, and the supplemental information of August 21, 2012. The above-referenced request, submitted in fulfillment of 19.15.29 NMAC (Rule 29, formally, Rule 116), indicates that Plains Marketing, L.P. (Plains) has partially met the requirements of 19.15.29 NMAC for this site. Therefore, the OCD hereby conditionally approves the soil closure for the Texaco Skelly 'F' Release Site and no further soil remediation is required for this site:

The Texaco Skelly 'F' Release Site is still active under Remediation Plan, 1R-420, and Plains must continue groundwater monitoring and remediation (and further groundwater characterization, if necessary).

Plains must cover the sumps with at least 3 feet of clean soil.
