

A sixteen (16)-inch low pressure natural gas pipeline developed a leak, resulting in a release of natural gas, crude oil and produced water. During initial response activities the pipeline was shut-in to mitigate the release. Following initial response activities, the affected pipeline segment was replaced with 200 linear feet of 16 inch polypipe

Describe Area Affected and Cleanup Action Taken *
The affected area is approximately 1,500 square feet. The release will be remediated according to NMOCD regulatory guidelines.
