The proposal for remediation of the above referenced produced fluid releases, as submitted on Alamo Permian's behalf by Tetra Tech, is approved with the following conditions and/or stipulations:

- Notify the OCD District 2 office 48 hours prior to commencement of remedial activities.
- Notify the OCD District 2 office 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- In the event the proposed excavation depths are not achieved, notify OCD to discuss options and/or alternatives.
- Notify OCD in a reasonable time, prior to backfilling excavations. Safety concerns will take precedent over notification requirements.
- Notify OCD 48 hours prior to any liner installation.
- Upon satisfactory completion of project/projects, submit to OCD, a Final Report Form C-141 and closure report.
- Project is to be completed and closure documentation submitted not later than April 16, 2012.
- Like approval by BLM, or any other regulatory authority as may be applicable.

Be advised, this approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, this approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
