*Administrative Order NSP-1890*

Dear Mr. Carr:

Reference is made to the following: (i) your application dated April 20, 2005 (*administrative application reference No. pSEM0-511246237*) on behalf of the operator, Nearburg Exploration Company, L.L.C. ("Nearburg"); and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Nearburg's request for the formation of the following described non-standard 280-acre deep gas spacing unit to be applicable to any and all formations and/or pools from the top of the Wolfcamp to the base of the Morrow formation that are:

- (1) developed on 320-acre spacing; and
- (2) governed under the provisions of Division Rule 104.C (2), which presently includes but is not necessarily limited to the Undesignated McKittrick Hills-Upper Pennsylvanian Gas Pool (81160), Undesignated McKittrick Hills-Strawn Gas Pool (81200), Undesignated McKittrick Hills-Atoka Gas Pool (81120), and Undesignated McIver Ranch-Morrow Gas Pool (81070):

**EDDY COUNTY, NEW MEXICO**  
**TOWNSHIP 22 SOUTH, RANGE 24 EAST, NMPM**  
**Section 24: SW/4, N/2 SE/4, and SW/4 SE/4.**

This unit is to be dedicated to Nearburg's proposed McKittrick "24" Federal Well No. 3, to be directionally drilled from a surface location somewhere within the NE/4 of Section 24 to a subsurface location within Unit "I" of Section 24 considered to be "standard" pursuant to Division Rules 104.C (2) (a) and 111.B (3).

This application has been duly filed under the provisions of Division Rule 104.D (2).

By the authority granted me under the provisions of Division Rule 104.D (2) (b), the above-described 280-acre non-standard deep gas spacing unit for any and all formations from the top of the Wolfcamp formation to the base of the Morrow formation for Nearburg's proposed McKittrick "24" Federal Well No. 3, is hereby approved.


