Dear Mr. Stogner

As per our recent phone conversation, Marathon Oil Company respectfully requests authorization to simultaneously dedicate 240 acres of the 320 acre J. L. Muncy lease in two separate tracts of 80 acres, and 160 acres for the production of multiple wells on each tract. The remaining 80 acres on the lease will be dedicated to a single well in the Tubb formation. Details of the break-down for these acreage dedications is included below, along with a brief well history for the Tubb gas wells involved in this plan. Plats showing the well designations for the entire 320 acres are attached. Copies of these C-102 plats will be sent along with a copy of this application letter to the NMOCD district office in Hobbs. Also attached to this application are maps of the lease area showing offset wells to the J. L. Muncy lease, and a list of offset operators.

The first tract of acreage that Marathon is requesting be dedicated to multiple wells is the 80 acres comprised of the S/2 of the NE/4 of Section 24, T-22-S, R-37-E. This tract will be dedicated to the J.L. Muncy No. 7 & No. 11 wells.

J.L. Muncy No.11 (30-025-33947) UL "G" 2310' FNL & 1980' FEL, Sec 24, T-22-S, R-37-E. This well is a downhole commingled (DHC No. 2750) Blinbry Oil & Gas / Tubb Gas well. This well was first brought on Tubb production on 08/26/2000 when a retrievable bridge plug was removed to downhole commingle the two zones. This well was the one that I referred to in our conversation as having never been correctly set-up in Marathon's reporting and allocation systems and thus not reported on the C-115 for Tubb gas production. We have since contacted Fran Chavez with the NMOC reporting group, and with her approval Marathon has sent amended reports for the Tubb gas volumes from January 2002 to the present time.

J.L. Muncy No. 7 (30-025-29219) UL "G" 2086' FNL & 1874' FEL, Sec 24, T-22-S, R-37-E. The No. 7 was re-completed on 08/13/2004 to the Tubb formation. The well is in the same unit letter as the No. 11. This well was completed to the Tubb due to the error in not recording the No. 11 in our system as a Tubb well. The initial completion on the No. 7 was to be as a Tubb oil well. The oil production volume had decreased in the first month of production to the point that the well would not qualify under GOR rules for the Tubb pool as an oil well and must be classed as a gas well. Thus Marathon is forced to seek the simultaneous dedication of this 80 tract to these two wells.

The second tract of acreage that Marathon is requesting be dedicated to multiple wells is the 160 acres comprised of the SE/4 of Section 24, T-22-S, R-37-E. This tract will be dedicated to J.L. Muncy well No.'s 1 & 6.

J.L. Muncy No. 1 (30-025-10440) UL "P" 660' FSL & 660' FEL, Sec 24, T-22-S, R-37-E. The No. 1 well has continually produced as Tubb well since 1954. The well was downhole commingled 11/06/1992 under DHC No. 874. The percentages on the downhole commingle order give the Tubb zone 0 % of the oil production in the well. This percentage clearly makes the well a Tubb gas well.

J.L. Muncy No. 6 (30-025-29218) UL "I" 1920' FSL & 330' FEL, Sec 24, T-22-S, R-37-E. The No. 6 well was originally drilled as Wantz Granite Wash oil well. On August 6, 1985, the well was completed as dual Blinebry Oil & Gas / Tubb Oil & Gas well. On January 19, 1993 the well was downhole commingled (DHC No. 873) in the Blinebry and Tubb pools. Although this well has been filed as a gas well on most regulatory filings to the NMOCD, the well has always been reported as an oil well tied to pool code 60240 on the C-115 production reports. The well has never produced oil or condensate in sufficient quantities to qualify as an oil well. The well is also not on a standard gas well spacing and the application for a non-standard location for this gas well is included in the mailing with this application for simultaneous dedication of acreage.

The remaining 80 acre tract on the J.L. Muncy lease represented by the E/2 of the SW/4 of Section 24, T-22-S, R-37-E. Will be dedicated to one well, the J.L. Muncy No. 2. This well is temporarily abandoned for the Tubb formation, but I have been informed by Ms. Donna Mull with the Hobbs NMOCD office, that because the formation has not been permanently abandoned it must be assigned acreage, and it is currently listed as being assigned acreage that we are requesting go to the other wells. Therefore we are asking it be re-dedicated to the 80 acre tract as indicted on this application and the accompanying C-102.

These three tracts with five wells complete the assignment of all 320 available acres on the Marathon Oil, J.L. Muncy lease.

A copy of this application letter, map, and plats have been sent to the offset operators which border the J.L. Muncy lease with instructions for contacting the NMOCD with any objections to the simultaneous dedication of acreage for these wells. The operator letters specify which wells each operator controls that correspond to the various plats. The IH Dwight's map sent to each operator indicates the location of their wells and the Marathon wells that correspond to them.

A list of operator's names and addresses, and copies of the letters to each one are included with this application. The operator name and address list also indicates the wells they are operating that correspond to the Marathon Oil Company wells submitted for simultaneous dedication. In addition a copy of the certified mail receipts for the letters mailed to these operators is also included with this application.

The J.L. Muncy No. 6 was first completed to the Tubb formation in August 1985 as a dual completed well with the Blinebry. It produced as a dual until November 1995. The well was downhole commingled in the Tubb and Blinebry formations in November 1995. This well was drilled and permitted as a Blinebry and Tubb oil well on oil well spacing. The well has always been reported on C-115 production reports as a Tubb oil well for the Tubb Oil & Gas Pool, but the well will not meet GOR requirements for an oil well in the Tubb pool. Therefore Marathon is seeking to have the well type changed to gas and requests that the well be given a non-standard location for a Tubb gas well.

The plat that accompanies this well shows that the wells will be simultaneously dedicated to the SW/4 of Section 24, T-22-S, R-37-E along with the J.L. Muncy No. 1 well. The application for simultaneous dedication of acreage accompanies this NSL application.

A copy of this application letter, map, and plat have been sent to the offset operators on which this location encroaches in Section 19, T-22-S, R-38-E with instructions for contacting the NMOCD with any objections. Copies of the letters to the operators, and a list of operators with names and addresses is included in this application. 

