

Manana Gas, Inc. proposes to drill a vertical well at the above listed location and test the Fruitland Coal and Pictured Cliffs formations. A 8-3/4" surface hole will be drilled to approx. 120' with spud mud. 7", 20# casing will be set and cemented to surface with 30 sx (36 cu.ft.) of CI "B" with 3% CaCl₂ and 1/4#/sk CF. A double ram, 2000 psi rated BOP will be installed and pressure tested to 600 psi. A 6-1/4" hole will be drilled using a fresh water - polymer mud system to approx. 1950'. 4-1/2", 10.5# casing will be set and cemented to surface with 145 sx (292 cu.ft.) of CI "B" cement with 2% SMS, 1/4 #/sk. celloflake and 5 #/sk gilsonite followed by 100 sx (118 cu.ft.) of CI "B" with 2% CaCl₂, 1/4 #/sk celloflake and 5 #/sk gilsonite. Open hole DIL and FDC/CNL/GR/SP logs will be run. Surveys will be run every 500'. The W/2 of Section 23 (320 acres) is dedicated to the Fruitland and the SW/4 is dedicated to the Pictured Cliffs. Formation tops: Ojo Alamo - 355', Kirtland - 405', FT -1375', PC - 1750'.





A wide shallow pit (25' X 60' X 4') will be lined with a 12 mil liner. After completion, the fluids will be removed and the cuttings will be allowed to dry. When the cuttings are dry the liner will be removed and the cuttings will be buried at the site. A ditch will be dug between the pit and the Animas River as a secondary / emergency containment facility.



04/16/05 Spud surface hole (8-3/4", Varel, L116-RR). Drilled to 135' KB and ran 3jts (124.80') of 7", 20#, J-55, ST&C casing and set at 134' KB. Cemented with 75 sx (106 cu.ft.) of Cl "B" with 2% CaCl₂ and 1/4 # sk celloflake. Circulated 5 bbls of good cement to surface. Hole was staying full.

04/18/05 Nipped up the BOP and pressure tested the casing and BOP to 600 psi.

04/20/05 TD well at 1890' KB.

04/21/05 Ran 49 jts (1879.22) of 4-1/2", 10.5#, J-55, ST&C casing and landed at 1887' KB. Insert float is at 1867' KB. Cemented with 225 sx (467 cu.ft.) of Cl "B" w/2% SMS, 5#/sx of gilsonite & 1/4#/sx of celloflake. Tailed with 100 sx (118 cu.ft.) of Class "B" w/2% CaCl₂ & 1/4#/sx of celloflake. Circulated 20bbls of cement to surface.




