Gentlemen:

McKay Oil Corp. desire to drill a location 510' from the north line, and 660' from the west line of Unit D in Sec. 15 of Township 6 South, Range 22 East, NMPM (See Attached Survey Plat). Due to topographical concerns and in an effort to reduce the surface impact, McKay Oil Corp. is requesting an unorthodox location (See Attached Location Verification Map).

The well was originally staked at 660' from the north line and 660' from the west line of Section 15. The location was on a severe slope and it was recommended by the Bureau of Land Management that the well be moved north and east to avoid excessive surface impact (See Rig Plat). Any location feasible to drill would have to be a non-standard location. Therefore, it is our opinion that this location would be the best economical and productive location to drill.


McKay Oil Corp. owns the operating rights surrounding the location, with the exception of the section west of this location, being Sec. 16, T6S, R22E, which is leased to Yates Petroleum Corp. (See Attach Land Map) Attached is a copy of the approval letter from Yates Petroleum Corp.

Therefore, McKay Oil Corporation is requesting that the OCD grant administrative approval to the unorthodox location at 510' form the north line and 660' from the west line in unit D of Section 15, Township 6 South, Range 22 East, NMPM. This location has been approved by the Southern New Mexico Archaeological Services, Inc. and the BLM.




LEASE FOUR MILE B DRAW FEDERAL






