The above named company is hereby authorized to surface commingle Penrose-Skelly (Grayburg) (Oil – 50350), Paddock (Oil – 49210), Southwest Eunice-San Andres (Oil – 24180) and Tubb Oil & Gas (Oil – 60240) Pool production from the following-described wells located on the Texaco E. A. Sticher and R. L. Clifton Fee Leases within the SW/4 of Section 4, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico:



The operator shall notify the Hobbs district office of the Division prior to implementing commingling operations.
