Pursuant to Division Rule 104.F(2), Bass Enterprises Production Co. applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Poker Lake Unit Well No. 244
<u>Location:</u>	2290 feet FSL & 100 feet FWL
<u>Well unit:</u>	NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 32, Township 24 South, Range 30 East, N.M.P.M., Eddy County, New Mexico


The well will be drilled to a depth sufficient to test the Delaware formation. The formation is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 for the well is attached as Exhibit A.

The location is based on topographical reasons. The location is in the flattest area of the well unit -- there are drop-offs to the north, south, and east. See Exhibit B.

The well is located on State Lease B-10685, which covers all of Section 32. Offsetting Section 31 is covered by Federal Lease LC 069627-A. Both leases are fully committed to the Poker Lake Unit, and as a result there is no adversely affected party. Therefore, notice has not been given to anyone.
