2410' FSL & 2175' FWL SEC. 35, T. 28 N., R. 4 W., RIO ARRIBA COUNTY, NM

I. The well is on U. S. Forest Service surface and on BLM oil and gas lease NMNM-14923. The proposed location is nonstandard for the Blanco Mesa Verde due to topography (large ponderosa pines). A standard location must be at least 660' from the acreage dedication line. This well is staked 430' further north than is standard. (Closest standard location would be 1980' FSL and 2175' FWL.) The APD cover sheet is attached as EXHIBIT A.

II. A C-102 showing the well location and acreage dedication unit (S2 Sec. 35) is attached (EXHIBIT B). The BLM oil and gas lease (640 acres) boundary is marked as a solid line on the attached (EXHIBIT C) copy of the Pine Lake USGS topo map.

The well encroaches on the north half of Section 35, which is part of the same lease. (Proposed NSL is 2175' from closest lease line.) Closest well is XTO's Valencia Canyon Unit 46 which is 1,753' northwest at 1975 FNL & 665 FWL of Section 35.

III. According to NM Oil Conservation Division records, the closest existing or planned Mesa Verde well is XTO's Valencia Canyon Unit 46, an existing Pictured Cliffs and Mesa Verde well which is 1,753' northwest at 1975' FNL & 665' FWL 35-28n-4w. EXHIBIT D shows the proposed NSL well site, Mesa Verde dedicated spacing units, and Mesa Verde wells (circled on map) within those dedications.

Registered letters were sent on July 25, 2005 to all of the offset interest owners. Copies of the postal receipts and letters are attached.

IV. A copy of the USGS map is attached (EXHIBIT D). The proposed well site is marked. Pro ration unit (solid line) for the Blanco Mesa Verde gas is the 320 acre south half of Section 35, Township 28 North, Range 4 West, Rio Arriba County, NM.

V. The nonstandard location is due to topography (trees). The drilling window is in a dense forest of large ponderosa pines. The location was




Name: PINE LAKE


