Describe Cause of Problem and Remedial Action Taken.*

DCP's MM gas pipeline was discovered to have burst in two separate locations 1500 feet apart. Crude oil spilled from the failure points and ran down a lease road. The probable cause is an overpressure followed by rupture at two corroded locations.

Describe Area Affected and Cleanup Action Taken.*

DCP's MM gas pipeline was discovered to have burst in two separate locations 1500 feet apart and 4 feet deep. Raw natural gas was released as well as approx. 60 bbls of crude that had entered the line from a producer. The two impacted areas are almost totally within the confines of a dirt lease road running in an east to west direction. The crude oil flowed west from each of the two release points. Bids are being obtained from cleanup contractors and once a selection is made a cleanup plan will be submitted to BLM for review and approval.
