Dear Mr. LeMay,

Texaco Exploration and Production Inc., respectfully requests administrative approval to downhole commingle the North Teague Tubb Associated and the North Teague Drinkard-Abo zones for the above captioned well.

At this time, the B. F. Harrison "B" #15 is dually completed in the Tubb and Drinkard-Abo zones. Production from the Tubb interval is on plunger lift while production from the Drinkard-Abo interval is flowing. Hydrocarbons from both zones are surface commingled in a storage facility located in UL C, Section 9, Tws., 23S, Rng., 37E. Texaco proposes to rod pump the downhole commingled production from both zones. This method of production will significantly decrease the casing pressure on the producing formations and allow for a more complete recovery of hydrocarbons. Consequently, the productive life of both intervals will be extended thus minimizing waste. For additional information, please refer to the attached acreage plats, C-116's, and list of offset operators.
