Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed Coffee Federal No. 12. This well will be drilled as a development oil well in the Cedar Lake Glorieta-Yeso Pool (96831).

The proposed Coffee Federal No. 12 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Cedar Lake Glorieta-Yeso Pool comprising the SE/4 NW/4 of Section 18. This unit is currently dedicated to Apache's existing Coffee Federal No. 2 (API No. 30-015-31058) located at an unorthodox well location 2410 feet from the North line and 2046 feet from the West line.

The Cedar Lake Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached C-102 plat shows that Section 18 is an irregular section due to a variation in the legal subdivision of the United States Public Lands Survey. The W/2 W/2 of Section 18 is comprised of four lots ranging in size from 32.01 acres to 32.33 acres. The distance from the west boundary to the center of Section 18 is approximately 2,380 feet, based upon a lot size of 32.11 acres.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid an existing pipeline.

The affected offset tracts are the NW/4 NE/4 and SW/4 NE/4 of Section 18. Both affected offset 40-acre tracts are currently being developed in the Cedar Lake Glorieta-Yeso Pool by numerous wells operated by Apache Corporation. Please note that the working interest ownership between the SE/4 NW/4 and the two affected offset 40-acre tracts is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 showing the proposed well, spacing unit, other existing wells in the spacing unit and the affected offset acreage. Also attached is a vicinity map.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Cedar Lake Glorieta-Yeso Pool underlying the SE/4 NW/4 of Section 18 that may otherwise not be recovered by the existing wells, thereby preventing waste, and will not violate correlative rights.




