

This e-mail is to notify the NMOCD of a leak that occurred on 12/3/12 at 2:00 p.m. at the Chesapeake (Chevron) Govt. D#4 battery. A hole in the discharge caused the release of 90 bbls of produced water. All of the fluids stayed inside the berm containment. Vacuum trucks are currently being used to recover as much fluid as possible. An initial C-141 will follow. A site delineation with soil sampling will be performed and then the OCD will be consulted with a remediation plan going forward.
