

Describe Cause of Problem and Remedial Action Taken.* The ball valve on the load line was partially left open causing a release of produced water. The ball valve has been closed.					
Describe Area Affected and Cleanup Action Taken.* Initially 15bbls of produced water were released from the ball valve at the load line and we were able to recover 12bbls with a vacuum truck. The location has been scraped and contaminated caliche has been hauled to disposal. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a work plan to the NMOCD/BLM for approval prior to any significant remediation work.
