

This is to inform you that Oxy Permian Primary had a produced water/oil leak on the Mobil Federal Battery on Monday January 14, 2013. Oxy released 60 bbls of oil, and 20 bbls of water due to SOUTH WATER TRANSFER PUMP VAPOR LOCKED CAUSING TANK TO OVER FLOW. LEAK IS INSIDE FIRE WALL AT THE BATTERY. The battery is located in SECT 29 T23S R31E of Eddy County. Oxy will do some initial remediation, a C-141 to follow. BBC International will delineate at a later date.
